Cromwell Singapore Holdings Pte. Ltd. ("CSHPL") is a wholly-owned subsidiary of CDPT Finance No. 2 Pty Ltd., which is in turn a wholly-owned subsidiary of Cromwell BT Pty Ltd (as custodian (aka bare trustee) for Cromwell Property Securities Limited as responsible entity for Cromwell Diversified Property Trust ("CDPT")). CDPT is part of Cromwell Property Group which is a stapled group comprising Cromwell Corporation Limited and CDPT. Accordingly, Cromwell Property Group is deemed to be interested in CSHPL's direct and deemed interests in the Units.

Additionally, the Manager is a wholly-owned subsidiary of Cromwell Corporation Limited. As such, Cromwell Property Group is also deemed to be interested in Cromwell Corporation Limited's deemed interests in the Units held by the Manager.

Pior to 1 June 2018, Redefine Global (Pty) Ltd held 22.5% of the issued stapled securities of Cromwell Property Group. As such, Redefine Global (Pty) Ltd was deemed to be interested in Cromwell Property Group's deemed interests in the Units. On 1 June 2018, Redefine Global (Pty) Ltd divested an approximately 19.5% interest in Cromwell Property Group. As such, Redefine Global (Pty) Ltd now holds an approximately 3.0% interest in Cromwell Property Group and is no longer deemed to be interested in Cromwell Property Group's deemed interests in the Units.
