CDPT is part of Cromwell Property Group which is a stapled group comprising Cromwell Corporation Limited and CDPT. Accordingly, Cromwell Property Group is deemed to be interested in CSHPL's interests in the Units.

Additionally, Cromwell EREIT Management Pte. Ltd. (the 'Manager') which holds 15,217,739 Units is a whollyowned subsidiary of Cromwell Corporation Limited. 
