Cromwell Singapore Holdings Pte. Ltd. ("CSHPL") holds 769,434,281 Units. CSHPL is a wholly-owned subsidiary of CDPT Finance No. 2 Pty Ltd, which is in turn a wholly-owned subsidiary of Cromwell BT Pty Ltd as custodian (aka bare trustee) for Cromwell Property Securities Limited as responsible entity for Cromwell Diversified Property Trust ("CDPT"). CDPT is part of Cromwell Property Group which is a stapled entity comprising Cromwell Corporation Limited and CDPT. Accordingly Cromwell Property Group is deemed to be interested in CHSPL's interests in the Units.

Cromwell EREIT Management Pte. Ltd. ("the Manager") is a wholly-owned subsidiary of Cromwell Corporation Limited. The Manager disposed of 6,824,055 Units and continues to hold 6,276,353 Units.

As such Cromwell Property Group is deemed to be interested in Cromwell Corporation Limited's deemed interests in the 6,824,055 Units disposed of by the Manager and in the 6,276,353 Units held by the Manager.

Cromwell CERIT Holdings Limited ("CCH") is a wholly-owned subsidiary of Cromwell Europe Limited, which in turn is a wholly-owned subsidiary of Cromwell European Holdings Limited, which in turn is a wholly-owned subsidiary of Cromwell Corporation Limited. CCH disposed of 15,999,861 Units.

As such Cromwell Property Group is deemed to be interested in Cromwell Corporation Limited's deemed interests in the 15,999,861 Units disposed of by CCH.
