From previous transactions, Worldwide Property Financing Limited directly owns 42,923,000 units in Cromwell European REIT, and Hillsboro Capital, Ltd. directly owns 186,590,000 units in Cromwell European REIT, bringing the total deemed interest to 229,513,000 units. On 19 February 2020, Worldwide Property Financing Limited sold 500,000 units in Cromwell European REIT. Hence, Mr Andrew L. Tan is currently the beneficial owner of 229,013,000 units in Cromwell European REIT.
