Lim Hwee Chiang holds 19.85% of the shares of ARA Asset Management Holdings Pte. Ltd. ("ARA Holdings") through JLIG and has on 2 June 2020 acquired shares in ARA Holdings through JLIG II (the "ARA Shares") which resulted in Lim Hwee Chiang holding more than 20.0% interest in ARA Holdings.

ARA Holdings holds 100% of the shares of ARA Investment (Cayman) Limited, which in turn holds 100% of the shares of ARA Asset Management Limited. ARA Asset Management Limited holds 100% of the shares of ARA RE Investment Group (Singapore) Pte. Ltd., which in turn holds 100% of the shares in ARA Real Estate Investors XXI Pte. Ltd. ("ARA RE 21") and ARA Real Estate Investors 28 Limited respectively.

As ARA RE 21 holds above 20.00% of Cromwell Property Group ("CPG") and CPG is deemed interested in 30.67% of the units in Cromwell European Real Estate Investment Trust ("CEREIT"), ARA RE 21 is deemed interested in 30.67% of the units in CEREIT through CPG.

As ARA RE Investment Group (Singapore) Pte. Ltd. holds 100% of ARA RE 21, it is also deemed interested in 30.67% of the units in CEREIT.

As ARA Asset Management Limited holds 100% of ARA RE Investment Group (Singapore) Pte. Ltd., it is also deemed interested in 30.67% of the units in CEREIT.

As ARA Investment (Cayman) Limited holds 100% of ARA Asset Management Limited, it is also deemed interested in 30.67% of the units in CEREIT.

As ARA Holdings holds 100% of ARA Investment (Cayman) Limited, it is also deemed interested in 30.67% of the units in CEREIT.

As Lim Hwee Chiang holds more than 20.0% interest in ARA Holdings, he is therefore also deemed interested in 30.67% of the units in CEREIT.
