Cromwell Singapore Holdings Pte. Ltd. ("CHSPL") has disposed of the 153,886,856 CEREIT units that it holds. CHSPL is a wholly owned-sub subsidiary of CDPT Finance No.2 Pty Ltd, which is in turn a wholly-owned subsidiary of Cromwell BT Pty Ltd (as custodian (aka bare trustee) for Cromwell Property Securities Limited as responsible entity for Cromwell Diversified Property Trust ("CDPT"). CDPT is part of Cromwell Property Group which is a stapled group comprising Cromwell Corporation Limited and CDPT. Accordingly Cromwell Property Group is deemed to be interested in CHSPL's interests in the CEREIT units.

Cromwell CEREIT Holdings Limited which has disposed of the 561,983 CEREIT units that it holds is a wholly owned subsidiary of Cromwell Europe Limited, which in turn is a wholly owned subsidiary of Cromwell Corporation Limited.

Cromwell Corporation Limited has disposed of all the shares it holds in Cromwell EREIT Management Pte. Ltd. (the "Manager") which holds 1,784,861 CEREIT units.

As such Cromwell Property Group was also deemed interested in Cromwell Corporation Limited's deemed interests in the 1,784,861 CEREIT units held by the Manager and the 561,983 CEREIT units formerly held by Cromwell CEREIT Holdings Limited.
